Sub: School Education - Meeting with private un-aided school managements (APUSMA) on 26-05-2015 in the office of the Commissioner of School Education - Decisions taken - Instructions issued - Reg.

Read: Minutes of the meeting held on 26-05-2015 with private un-aided school managements (APUSMA).

The Regional Joint Directors of School Education and the District Educational Officers in the State are informed that a meeting was conducted on 26-05-2015 in the office of the Commissioner of School Education, Hyderabad to solve the problems of private unaided schools of the State. In the meeting a few decisions were taken to ease the procedure in establishment of new school or to obtaining recognition for the existing schools.

They are, further, informed that as per A.P Education Rules issued in G.O.Ms.No.1, Education, dt:01-01-1994, read with G.O.Ms.No.123, Education, dt:29-09-2008 for establishment of a new school or for up-gradation of existing school or for obtaining recognition to the existing school the managements have to submit the No-Objection Certificate issued by the competent authority.

Under Section.13 of A.P. Fire Services Act 2006 a smilding of public congregation like schools, which are more than 500 sq.mtrs in plot area or 6 mts and above in height, have to obtain No-Objection Certificate from the Fire Services Department. The Fire Services Department has prescribed the competency for issuing NOC basing on the height of the building. In these rules there is no mention about the requirement of NOC for the building with height less than 6 mts.

In view of the above, it is proposed to exempt the schools, only with ground floor, from producing NOC of the Fire Department for obtaining recognition/permission subject to condition that all the required fireflecting equipment is to be provided (under point No.2 of the minutes of the meeting). But, the schools in jam-packed areas (municipal Corporations) have to obtain NOC from the Rire Services Departments.

Besides, they are informed that as per Rule 9 (5) of G.O.Ms.No.1, Education, dt:01-01-1994 the recognition shall be valid for the period of ten academic years and the educational agency shall, before the expiry of recognition, seek renewal of recognition. The RJDSE/DEO, as the case may be, has to accord recognition for 10 years subject to fulfillment of all the conditions, prescribed under rules.

The Regional Joint Directors of School Education and the District Educational Officers of the State are, therefore, requested to execute as per the above decisions.

This has the approval of the Commissioner of School Education, Andhra Pradesh, Hyderabad.

In continuation of this Office reference 1st cited, it is to inform that, all the Educational Institutions like Schools and College, which are less than 500 Sq Meters in Plot area (or) less than 06.00 Meters in height of the Building of Ground Floor + 1st Floor only are not required to take Fixe No Objection Certificates from this Department.

- 2) However, keeping in view of the Safety of the School Children the following Fire Safety Measures shall be ensured by taking self declaration from the concerned School Principal /-Head Master.
  - i) Minimum (2) Extinguishers of ABC Type shall be provided in the Premises
  - ii) Minimum (2) Sand Buckets and (2) Water Buckets shall be having to a stand in the premises.
